VILLAGE BOARD COMMITTEE REPORTS

- a) Planning/Zoning Trustee Robinson notified that there will be a Zoning Board of Appeals meeting on March 9 that will include public hearings for the Oakstead Subdivision as well as two zoning code text amendments to amend signage requirements in the Interchange Overlay District and to combine the ZBA and Plan Commission into one body.
 - On March 18 at 7 p.m., the Village Board will have a public hearing for the Oakstead Subdivision before considering approval of the amendment to the 2005 annexation agreement.
- b) <u>Public Safety</u> Police Chief Thompson reported the department is working on a few cases, but information is still confidential until further progress is made. Other than that, everything is going well.

- d) <u>Village Services</u> Trustee Kelly mentioned the committee will be having a quick meeting on March 9 at 5 p.m. to discuss if we should renew the contract with Waste Management or go out for bid.
- e) <u>Public Works</u> Trustee Koth reported one of the plow trucks is getting repairs done again, and another one exploded oil into the cab fortunately, no one was in it at the time. Streets will be receiving more salt soon even though the season is mostly over due to the state-mandated purchase agreement.

f) <u>Business Development</u> – Trustee Krajecki reported the BDC will meet on March 10 at 6:30 PM to continue reviewing the 2004 Comprehensive Plan and thinking of future commercial land use. The commission will also be working on the new CEO ambassador program as well as the new entrepreneurship program. There may also be another business owner interested in the façade improvement program.

The Chamber of Commerce will also go live with its version of the new branding on March 10.

ANNOUNCEMENTS

Village Manager Hedges reported that staff will have a "walkabout" meeting next week with EEI and PRI to discuss the Streetscape plans and schedule.

Trustee Klein inquired about the Greer Farm on Route 20. Mr. Hedges noted that the owners would like to put crushed asphalt in for their driveway, which is taking time to engineer from scratch. They do know they need to move their large equipment and bring the rest of the property up to code.

Trustee Robinson asked about the zoning process for future apartments that may be going up at Route 72 and Romke Road. Village President Magnussen reported that the conversations are in the very early concept stage, so no action needs to be taken yet.

Trustee Kelly expressed an interest in developing a collaboration strategy within the Village organization using MS Teams and SharePoint. Mr. Hedges said he has wanted to start fully

utilizing those tools since he started. It just has not been a top priority yet, but it will be as other priorities start to closeout.
