Supporting Local Businesses Through COVID

- Trustee Krajecki discussed that with the rises in COVID-19 cases up, the Village Board would like the BDC's thoughts in assisting local businesses.
- To date, the Village has purchase \$5,000 worth of local gift cards to local businesses, provide a program to allow 50% reimbursement on the installation of walk-up windows (up to \$3k match) and bringing mobile test sites to the Village
- Bars & restaurants business is being hurt by competition from neighboring communities due to their laxer policies
- The BDC brainstormed the following ideas, of which Village Administrator Hedges will bring to the Chamber of Commerce:
 - Restaurants banding together by offering a delivery service to neighboring communities; potential for the Village to subsidize the delivery
 - Business offering lunch specials to businesses in the area
 - Bars to offer a to-go drink pack; can be combines with a social media contest with voting.

Property Code Enforcement Update

- Out of courtesy and before each are cited, Village Administrator Hedges reached out to the property owners of both the former dollar store and former Palazzolo's to provide them insight that they will be cited for the current status of their facades.
- He has spoken with both owners and each have confirmed that they will or have plans underway to fix their facades. The situation will be monitored and followed up if a lack of progress occurs.
