# VILLAGE BOARD COMMITTEE REPORTS

#### a. Public Works

Trustee Koth announced the Lots 5 & 6 on Ketchum will not work for the Fire Department or for the village; the pipeline is only 3 feet deep and needs to go deeper. The cost will run into the millions. Therefore, the fire department and the village are all pulling out of the deal and we will put our building on Klick Street.

Information regarding a trucks leasing company: we can have 3 new trucks for plowing at a price of \$158,000 each year for 3 years.

### b. Planning/Zoning

Trustee Robinson reported ZBA will have a meeting on March 12 deciding on issuing of a sign variance for Lucky Energy Service, who took over Elburn CO-OP at 261 Mill Street.

A Planning and Zoning Committee meeting will be held on Wednesday, March 13 at 5:30 at Hampshire Village Hall to discuss dual zoning, beer gardens, and administrative adjudication.

#### c. Public Safety

There is still a silt fence at the first pond in Tuscany Woods. The clerk will call HOA and have them remove it.

Trustee Kraus reported that she brought Jody Remakel to the village board meeting to talk about Dial & Ride. Right now we have only one person using it. They are thinking of shifts of 8:00 AM to 12:00 PM then 12:00 PM to 4:00 PM so we can help high school kids who need a ride to Elgin Community College and have a drop off point somewhere on Randall Road, too.

Trustee Reid will work with Jody since he has contacts with School District 300.
