# Meeting Minutes Approval From 3/10/21:

# **BDC Ambassador Program**

 Commissioner Trzaska presented a draft of a joint letter between the BDC and the Chamber of Commerce to send out to local businesses to introduce the BDC and connect with local businesses on a collaboration/input program. Commissioner Trzaska will look to finalize the letter, review the business list and bring forward a recommendation on a distribution method to May's meeting.

### **Commercial Land Development**

- Commissioner Pizzolato reviewed with the Commission the EPA "FRAMEWORK FOR CREATING A SMART GROWTH ECONOMIC DEVELOPMENT STRATEGY: A TOOL FOR SMALL CITIES AND TOWNS" as a recommended tool for the BDC to use for commercial development.
- The BDC discussed the need of detailing the recommended areas, usage and criteria for land to be considered as commercial within the Village. Commissioner Pizzolato will develop a location map of potential commercial locations throughout the Village and a guideline list for the BDC to review at May's meeting.

# Entrepreneurial Discussion

- Commissioner Thomas shared her research in attracting entrepreneurs to Hampshire. She connected with a D300 representative and discussed the programs that entice entrepreneurship with students. The group discussed ideas that could engage this younger audience within the Village through outreach with local schools.
- Commissioner Thomas also announced her resignation from the BDC and the Commission expressed their appreciation for her contribution through her tenure.

### Marketing Brochure Update

• Village Administrator Hedges provided an update that the brochure is now complete and is waiting to be printed until the Village new board is in place in May.

### Beautification Committee Report

- Commissioner Swalwell presented the following updates:
  - Farmers Insurance owner Roger Larson has approached Commissioner Swalwell about updating his façade. More details to come after the proposal & bids are reviewed.
  - Palazzolo's owners have a meeting set for Friday 4/16. Updates will come at May's meeting.
  - The new owner of a doctor's office on main street has inquired about the façade program. An application has been submitted, but more documentation is required.
  - Dollar Store Village Administrator Hedges discussed the current status of their property with the owners and they seem ready to proceed with an application.
  - Trustee Krajecki discussed a recent inquiry from a business owner outside the current façade district. The group recommends that the district does not change at this time, due to the amount of work that needs the funds within the current district.

### Property Code Enforcement Update

• Though work has not been completed yet, both the downtown Dollar Store and the former Palazzolo's owners have been in touch and will look to be updating their façades.

#### New or Existing Business Update

- Village Administrator Hedges provided an update for the streetscape project, which included:
  - Sidewalks will be left in place
  - Detours will direct traffic for 3 months of the project; semi-truck traffic will be prohibited.
  - The board recommended businesses open signage during construction
- Freight Union is bringing their headquarters to the industrial park and Gast & Flannigan roads.
