

1. Call to Order

4. Approval of Minutes from January 30, 2019

Trustee Reid motioned to approve minutes. Motion seconded by Trustee Robinson

c. Property maintenance and zoning discussion

Administrative Adjudication

- Trustee Krajecki attended a seminar on property maintenance
- James W. Binninger (former attorney of Hanover Park) presented at seminar

- Courts do not want property maintenance cases.
- Courts would much rather villages handle property maintenance issues in house through administrative adjudication
- We would like to work with Mr. Schuster to set this program up for Hampshire
 - o Genoa is interested in this program
 - o Perhaps a partnership between Hampshire and Genoa?
- Benefits far outweigh the costs
 - o Court costs are very large
