Main Street Program - Updates

- Building Inventory Program Location One (LOIS): Trustee Krajecki shared that he had been able to have conversation with Bryan Mrock, and that he is interested in helping the commission. He was not able to attend the meeting due to the date change, however Trustee Krajecki and Mroch plan on talking after the Village Meeting on Thursday night
- The Commission reviewed the list of invitees once again and added several names to the list. Trustee Krajecki is aiming to get the list of invitees to the Village Clerk this week in order that we can get the invites out.
- The Commission finalized the agenda and assigned the different sections to certain trustees who will be responsible for that part of the meeting.

 - Trustee Krajecki presented the two different proposals received by Commissioner Pizzolato. The group was discussed that they thought if we could fill 12 pages worth of material the price difference was fine.

- Trustee Krajecki also discussed that he spoke with Jeannie Mayer and she is willing to do the write ups for us, but we needed to get her more information. She expected the cost not to exceed \$500
- The commission voted unanimously to forward the proposal to the Village Board.

Information on Meeting with Senator Dewitte

 Trustee Krajecki shared information regarding the meeting with Senator Dewitte's. The Senator visited Village Hall the previous week and answered questions from residents. He also mentioned that he has submitted our connection of the North and South Water Main as part of his member initiative portion of the Capital Bill. He seemed optimistic, but we won't know for sure until the future.

Beautification Committee Report

- Swalwell reported back on updates for the Façade Program applicants
 - Harvest Real Estate has completed their project and submitted request for payment
 - Les Peterson project should be completed before winter. He has a permit hanging in the window
 - Swalwell says that the Speckled Fawn project is waiting on the landlord to sign the application. He does not expect that project to be completed until spring due to the delay
 - Swalwell spoke to the owner of Blocks, and they said due to the amount of money they had to put into the inside, they are delaying the work on the outside. He hopes next year sometime
 - Krajecki and Swalwell agreed to go out and knock on some doors in the downtime later in the month.
- Commissioner Swalwell said he will be setting up a meeting to dive into wayfinding topic again. He had hoped to combine it with the meeting with Speckled Fawn but at this point it makes sense just to address the wayfinding signs.

ESRI Reports

- Trustee Krajecki reported good news that that ESRI had, through a promotion they were running, allowed the Village to get the reports for free this year.
- They have been downloaded and sent to Mike Reid. We are waiting on him to post them
